












Figure 7 Rel. Lumin. Intensity vs.
Forw. Current/Duty Cycle




Figure 8 Relative Luminous Intensity vs. Forward Current




Figure 9 Relative Luminous Intensity vs. Wavelength




Figure 10 Forward Current vs. Forward Voltage




Figure 11 Rel. Luminous Intensity vs.
Ambient Temperature




Figure 12 Rel. Lumin. Intensity vs.
Forw. Current/Duty Cycle




Figure 13 Relative Luminous Intensity vs.
Forward Current




Figure 14 Relative Luminous Intensity vs. Wavelength




Figure 15 Rel. Luminous Intensity vs.
Ambient Temperature




Figure 16 Rel. Luminous Intensity vs.
Ambient Temperature




Figure 17 Rel. Lumin. Intensity vs.
Forw. Current/Duty Cycle




Figure 18 Relative Luminous Intensity vs.
Forward Current




Figure 19 Relative Luminous Intensity vs. Wavelength




Figure 20 Forward Current vs. Forward Voltage




Figure 21 Rel. Luminous Intensity vs.
Ambient Temperature






Figure 22 Specific Luminous Intensity vs.


Figure 23 Relative Luminous Intensity vs.


Figure 24 Relative Luminous Intensity vs. Wavelength


Figure 25 Forward Current vs. Forward Voltage

Forward Current




Figure 28 Relative Luminous Intensity vs.
Forward Current







Figure 29 Relative Luminous Intensity vs. Wavelength


