## DESCRIPTION

The TPA2010D1 (sometimes referred to as TPA2010) is a $2.5-\mathrm{W}$ high efficiency filter-free class-D audio power amplifier (class-D amp) in a $1,45 \mathrm{~mm} \times 1,45 \mathrm{~mm}$ wafer chip scale package (WCSP) that requires only three external components.
Features like 88\% efficiency, $-75-\mathrm{dB}$ PSRR, improved RF-rectification immunity, and $8 \mathrm{~mm}^{2}$ total PCB area make the TPA2010D1 (TPA2010) class-D amp ideal for cellular handsets. A fast start-up time of 1 ms with minimal pop makes the TPA2010D1 (TPA2010) ideal for PDA applications.

In cellular handsets, the earpiece, speaker phone, and melody ringer can each be driven by the TPA2010D1. The TPA2010D1 allows independent gain while summing signals from seperate sources, and has a low $36 \mu \mathrm{~V}$ noise floor, A -weighted.

## APPLICATION CIRCUIT



These devices have limited built-in ESD protection. The leads should be shorted together or the device placed in conductive foam during storage or handling to prevent electrostatic damage to the MOS gates.

## APPLICATION INFORMATION

## FULLY DIFFERENTIAL AMPLIFIER

The TPA2010D1 is a fully differential amplifier with differential inputs and outputs. The fully differential amplifier consists of a differential amplifier and a common-mode amplifier. The differential amplifier ensures that the amplifier outputs a differential voltage on the output that is equal to the differential input times the gain. The common-mode feedback ensures that the common-mode voltage at the output is biased around $\mathrm{V}_{\mathrm{DD}} / 2$ regardless of the common-mode voltage at the input. The fully differential TPA2010D1 can still be used with a single-ended input; however, the TPA2010D1 should be used with differential inputs when in a noisy environment, like a wireless handset, to ensure maximum noise rejection.

## Advantages of Fully Differential Amplifiers

- Input-coupling capacitors not required:
- The fully differential amplifier allows the inputs to be biased at voltage other than mid-supply. For example, if a codec has a midsupply lower than the midsupply of the TPA2010D1, the common-mode feedback circuit will adjust, and the TPA2010D1 outputs will still be biased at midsupply of the TPA2010D1. The inputs of the TPA2010D1 can be biased from 0.5 V to $\mathrm{V}_{\mathrm{DD}}-0.8 \mathrm{~V}$. If the inputs are biased outside of that range, input-coupling capacitors are required.
- Midsupply bypass capacitor, $\mathrm{C}_{\text {(BYPASS) }}$, not required:
- The fully differential amplifier does not require a bypass capacitor. This is because any shift in the midsupply affects both positive and negative channels equally and cancels at the differential output.
- Better RF-immunity:
- GSM handsets save power by turning on and shutting off the RF transmitter at a rate of 217 Hz . The transmitted signal is picked-up on input and output traces. The fully differential amplifier cancels the signal much better than the typical audio amplifier.


## COMPONENT SELECTION

Figure 27 shows the TPA2010D1 typical schematic with differential inputs and Figure 28 shows the TPA2010D1 with differential inputs and input capacitors, and Figure 29 shows the TPA2010D1 with single-ended inputs. Differential inputs should be used whenever possible because the single-ended inputs are much more susceptible to noise.

## Input Resistors ( $\mathbf{R}_{\mathbf{I}}$ )

The input resistors $\left(R_{1}\right)$ set the gain of the amplifier according to Equation 1.

Resistor matching is very important in fully differential amplifiers. The balance of the output on the reference voltage depends on matched ratios of the resistors. CMRR, PSRR, and cancellation of the second harmonic distortion diminish if resistor mismatch occurs. Therefore, it is recommended to use $1 \%$ tolerance resistors or better to keep the performance optimized. Matching is more important than overall tolerance. Resistor arrays with $1 \%$ matching can be used with a tolerance greater than $1 \%$.
Place the input resistors very close to the TPA2010D1 to limit noise injection on the high-impedance nodes.
For optimal performance the gain should be set to $2 \mathrm{~V} / \mathrm{V}$ or lower. Lower gain allows the TPA2010D1 to operate at its best, and keeps a high voltage at the input making the inputs less susceptible to noise.

## Decoupling Capacitor ( $\mathrm{C}_{\mathrm{s}}$ )

The TPA2010D1 is a high-performance class-D audio amplifier that requires adequate power supply decoupling to ensure the efficiency is high and total harmonic distortion (THD) is low. For higher frequency transients, spikes, or digital hash on the line, a good low equivalent-series-resistance (ESR) ceramic capacitor, typically 1 $\mu \mathrm{F}$, placed as close as possible to the device $\mathrm{V}_{\mathrm{DD}}$ lead works best. Placing this decoupling capacitor close to the TPA2010D1 is very important for the efficiency of the class-D amplifier, because any resistance or inductance in the trace between the device and the capacitor can cause a loss in efficiency. For filtering lower-frequency noise signals, a $10 \mu \mathrm{~F}$ or greater capacitor placed near the audio power amplifier would also help, but it is not required in most applications because of the high PSRR of this device.

## Input Capacitors ( $\mathrm{C}_{\mathrm{I}}$ )

The TPA2010D1 does not require input coupling capacitors if the design uses a differential source that is biased from 0.5 V to $\mathrm{V}_{\mathrm{DD}}-0.8 \mathrm{~V}$ (shown in Figure 27). If the input signal is not biased within the recommended common-mode input range, if needing to use the input as a high pass filter (shown in Figure 28), or if using a single-ended source (shown in Figure 29), input coupling capacitors are required.
The input capacitors and input resistors form a high-pass filter with the corner frequency, $f_{c}$, determined in Equation 2.

The value of the input capacitor is important to consider as it directly affects the bass (low frequency) performance of the circuit. Speakers in wireless phones cannot usually respond well to low frequencies, so the corner frequency can be set to block low frequencies in this application.
Equation 3 is reconfigured to solve for the input coupling capacitance.

If the corner frequency is within the audio band, the capacitors should have a tolerance of $\pm 10 \%$ or better, because any mismatch in capacitance causes an impedance mismatch at the corner frequency and below.
For a flat low-frequency response, use large input coupling capacitors ( $1 \mu \mathrm{~F}$ ). However, in a GSM phone the ground signal is fluctuating at 217 Hz , but the signal from the codec does not have the same 217 Hz fluctuation. The difference between the two signals is amplified, sent to the speaker, and heard as a 217 Hz hum.

## SUMMING INPUT SIGNALS WITH THE TPA2010D1

Most wireless phones or PDAs need to sum signals at the audio power amplifier or just have two signal sources that need separate gain. The TPA2010D1 makes it easy to sum signals or use separate signal sources with different gains. Many phones now use the same speaker for the earpiece and ringer, where the wireless phone would require a much lower gain for the phone earpiece than for the ringer. PDAs and phones that have stereo headphones require summing of the right and left channels to output the stereo signal to the mono speaker.

## Summing Two Differential Input Signals

Two extra resistors are needed for summing differential signals (a total of 5 components). The gain for each input source can be set independently (see Equation 4 and Equation 5), and Figure 30).

If summing left and right inputs with a gain of $1 \mathrm{~V} / \mathrm{V}$, use $\mathrm{R}_{11}=\mathrm{R}_{12}=300 \mathrm{k} \Omega$.

If summing a ring tone and a phone signal, set the ring-tone gain to Gain $2=2 \mathrm{~V} / \mathrm{V}$, and the phone gain to gain $1=0.1 \mathrm{~V} / \mathrm{V}$. The resistor values would be. . .

## Summing a Differential Input Signal and a Single-Ended Input Signal

Figure 31 shows how to sum a differential input signal and a single-ended input signal. Ground noise can couple in through IN+ with this method. It is better to use differential inputs. The corner frequency of the single-ended input is set by $\mathrm{C}_{12}$, shown in Equation 8. To assure that each input is balanced, the single-ended input must be driven by a low-impedance source even if the input is not in use

## Summing Two Single-Ended Input Signals

Four resistors and three capacitors are needed for summing single-ended input signals. The gain and corner frequencies ( $\mathrm{f}_{\mathrm{c} 1}$ and $\mathrm{f}_{\mathrm{c} 2}$ ) for each input source can be set independently (see Equation 11 ) through Equation 14, and (Figure 32). Resistor, $\mathrm{R}_{\mathrm{P}}$, and capacitor, $\mathrm{C}_{\mathrm{P}}$, are needed on the $\mathrm{IN}+$ terminal to match the impedance on the IN - terminal. The single-ended inputs must be driven by low impedance sources even if one of the inputs is not outputting an ac signal.

## BOARD LAYOUT

In making the pad size for the WCSP balls, it is recommended that the layout use nonsolder mask defined (NSMD) land. With this method, the solder mask opening is made larger than the desired land area, and the opening size is defined by the copper pad width. Figure 33 and Table 2 show the appropriate diameters for a WCSP layout. The TPA2010D1 evaluation module (EVM) layout is shown in the next section as a layout example.

## NOTES:

1. Circuit traces from NSMD defined PWB lands should be $75 \mu \mathrm{~m}$ to $100 \mu \mathrm{~m}$ wide in the exposed area inside the solder mask opening. Wider trace widths reduce device stand off and impact reliability.
2. Recommend solder paste is Type 3 or Type 4.
3. Best reilability results are achieved when the PWB laminate glass transition temperature is above the operating the range of the intended application.
4. For a PWB using a Ni/Au surface finish, the gold thickness should be less $0.5 \mu \mathrm{~m}$ to avoid a reduction in thermal fatigue performance.
5. Solder mask thickness should be less than $20 \mu \mathrm{~m}$ on top of the copper circuit pattern.
6. Best solder stencil preformance is achieved using laser cut stencils with electro polishing. Use of chemically etched stencils results in inferior solder paste volume control.
7. Trace routing away from WCSP device should be balanced in $X$ and $Y$ directions to avoid unintentional component movement due to solder wetting forces.

## Component Location

Place all the external components very close to the TPA2010D1. The input resistors need to be very close to the TPA2010D1 input pins so noise does not couple on the high impedance nodes between the input resistors and the input amplifier of the TPA2010D1. Placing the decoupling capacitor, CS, close to the TPA2010D1 is important for the efficiency of the class-D amplifier. Any resistance or inductance in the trace between the device and the capacitor can cause a loss in efficiency.

## Trace Width

Recommended trace width at the solder balls is $75 \mu \mathrm{~m}$ to $100 \mu \mathrm{~m}$ to prevent solder wicking onto wider PCB traces. Figure 34 shows the layout of the TPA2010D1 evaluation module (EVM).
For high current pins ( $\mathrm{V}_{\mathrm{DD}}$, GND $\mathrm{V}_{\mathrm{O}_{+}}$, and $\mathrm{V}_{\mathrm{O}}$ ) of the TPA2010D1, use $100-\mu \mathrm{m}$ trace widths at the solder balls and at least $500-\mu \mathrm{m}$ PCB traces to ensure proper performance and output power for the device.
For input pins (IN-, IN+, and SHUTDOWN) of the TPA2010D1, use $75-\mu \mathrm{m}$ to $100-\mu \mathrm{m}$ trace widths at the solder balls. IN - and $\mathrm{IN}+$ pins need to run side-by-side to maximize common-mode noise cancellation. Placing input resistors, $\mathrm{R}_{\mathrm{IN}}$, as close to the TPA2010D1 as possible is recommended.

## EFFICIENCY AND THERMAL INFORMATION

The maximum ambient temperature depends on the heat-sinking ability of the PCB system. The derating factor for the YEF and YEZ packages are shown in the dissipation rating table. Converting this to $\Theta_{\mathrm{JA}}$ :

Given $\Theta_{\mathrm{JA}}$ of $128.2^{\circ} \mathrm{C} / \mathrm{W}$, the maximum allowable junction temperature of $125^{\circ} \mathrm{C}$, and the maximum internal dissipation of $0.4 \mathrm{~W}(2.25 \mathrm{~W}, 4-\Omega$ load, $5-\mathrm{V}$ supply, from Figure 3), the maximum ambient temperature can be calculated with the following equation.

Equation 18 shows that the calculated maximum ambient temperature is $73.7^{\circ} \mathrm{C}$ at maximum power dissipation with a $5-\mathrm{V}$ supply and $4-\Omega$ a load, see Figure 3. The TPA2010D1 is designed with thermal protection that turns the device off when the junction temperature surpasses $150^{\circ} \mathrm{C}$ to prevent damage to the IC. Also, using speakers more resistive than $4-\Omega$ dramatically increases the thermal performance by reducing the output current and increasing the efficiency of the amplifier.

## ELIMINATING THE OUTPUT FILTER WITH THE TPA2010D1

This section focuses on why the user can eliminate the output filter with the TPA2010D1.

## Effect on Audio

The class-D amplifier outputs a pulse-width modulated (PWM) square wave, which is the sum of the switching waveform and the amplified input audio signal. The human ear acts as a band-pass filter such that only the frequencies between approximately 20 Hz and 20 kHz are passed. The switching frequency components are much greater than 20 kHz , so the only signal heard is the amplified input audio signal.

## Traditional Class-D Modulation Scheme

The traditional class-D modulation scheme, which is used in the TPA005Dxx family, has a differential output where each output is 180 degrees out of phase and changes from ground to the supply voltage, $\mathrm{V}_{\mathrm{DD}}$. Therefore, the differential pre-filtered output varies between positive and negative $\mathrm{V}_{\mathrm{DD}}$, where filtered $50 \%$ duty cycle yields 0 volts across the load. The traditional class-D modulation scheme with voltage and current waveforms is shown in Figure 35. Note that even at an average of 0 volts across the load ( $50 \%$ duty cycle), the current to the load is high causing a high loss and thus causing a high supply current.

## TPA2010D1 Modulation Scheme

The TPA2010D1 uses a modulation scheme that still has each output switching from 0 to the supply voltage. However, OUT+ and OUT- are now in phase with each other with no input. The duty cycle of OUT+ is greater than $50 \%$ and OUT- is less than $50 \%$ for positive voltages. The duty cycle of OUT+ is less than $50 \%$ and OUTis greater than $50 \%$ for negative voltages. The voltage across the load sits at 0 volts throughout most of the switching period greatly reducing the switching current, which reduces any $I^{2} R$ losses in the load.

## Efficiency: Why You Must Use a Filter With the Traditional Class-D Modulation Scheme

The main reason that the traditional class-D amplifier needs an output filter is that the switching waveform results in maximum current flow. This causes more loss in the load, which causes lower efficiency. The ripple current is large for the traditional modulation scheme because the ripple current is proportional to voltage multiplied by the time at that voltage. The differential voltage swing is $2 \times \mathrm{V}_{\mathrm{DD}}$ and the time at each voltage is half the period for the traditional modulation scheme. An ideal LC filter is needed to store the ripple current from each half cycle for the next half cycle, while any resistance causes power dissipation. The speaker is both resistive and reactive, whereas an LC filter is almost purely reactive.
The TPA2010D1 modulation scheme has very little loss in the load without a filter because the pulses are very short and the change in voltage is $V_{D D}$ instead of $2 \times V_{D D}$. As the output power increases, the pulses widen making the ripple current larger. Ripple current could be filtered with an LC filter for increased efficiency, but for most applications the filter is not needed.
An LC filter with a cutoff frequency less than the class-D switching frequency allows the switching current to flow through the filter instead of the load. The filter has less resistance than the speaker that results in less power dissipated, which increases efficiency.

## Effects of Applying a Square Wave Into a Speaker

If the amplitude of a square wave is high enough and the frequency of the square wave is within the bandwidth of the speaker, a square wave could cause the voice coil to jump out of the air gap and/or scar the voice coil. A $250-\mathrm{kHz}$ switching frequency, however, is not significant because the speaker cone movement is proportional to $1 / f^{2}$ for frequencies beyond the audio band. Therefore, the amount of cone movement at the switching frequency is very small. However, damage could occur to the speaker if the voice coil is not designed to handle the additional power. To size the speaker for added power, the ripple current dissipated in the load needs to be calculated by subtracting the theoretical supplied power, $\mathrm{P}_{\text {SUP THEORETICAL }}$, from the actual supply power, $\mathrm{P}_{\text {SUP }}$, at maximum output power, Pout. The switching power dissipated in the speaker is the inverse of the measured efficiency, $\eta_{\text {measured }}$, minus the theoretical efficiency, $\eta_{\text {theoretical- }}$.

The maximum efficiency of the TPA2010D1 with a 3.6 V supply and an $8-\Omega$ load is $86 \%$ from Equation 22 Using equation Equation 21 with the efficiency at maximum power ( $84 \%$ ), we see that there is an additional 17 mW dissipated in the speaker. The added power dissipated in the speaker is not an issue as long as it is taken into account when choosing the speaker.

## When to Use an Output Filter

Design the TPA2010D1 without an output filter if the traces from amplifier to speaker are short. The TPA2010D1 passed FCC and CE radiated emissions with no shielding with speaker trace wires 100 mm long or less. Wireless handsets and PDAs are great applications for class-D without a filter.
A ferrite bead filter can often be used if the design is failing radiated emissions without an LC filter, and the frequency sensitive circuit is greater than 1 MHz . This is good for circuits that just have to pass FCC and CE because FCC and CE only test radiated emissions greater than 30 MHz . If choosing a ferrite bead, choose one with high impedance at high frequencies, but very low impedance at low frequencies.
Use an LC output filter if there are low frequency ( $<1 \mathrm{MHz}$ ) EMI sensitive circuits and/or there are long leads from amplifier to speaker.

Figure 37 and Figure 38 show typical ferrite bead and LC output filters.
